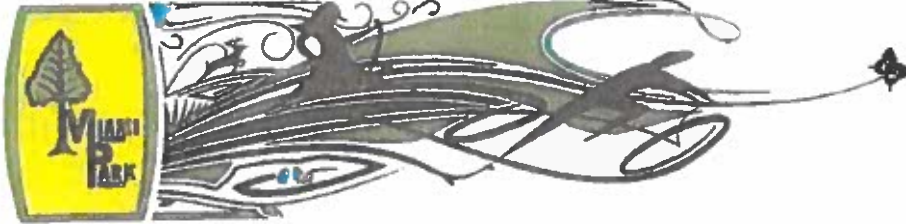

I am writing to express support for the City of Troy's Great Miami River Recreation Connectivity Project, to be submitted to the Dayton Development Coalition Priority Development Advocacy Committee (PDAC) review process.

Troy and MCD have a long and strong partnership in investing in the riverfront, starting in flood protection in the early 1900s to creating the first mile of paved recreational trail along the banks of the Great Miami River in 1972. That first mile of trail has grown to become the nation's largest system of connected paved trails with 340 total miles which now draws people from all over the country to bike on protected cycle lanes. In 2014, the City invested \$10 million dollars to improve public access at Treasure Island Marina, leading to greater usage on both sides of the river, and inspiring programs like Float Troy.

MCD is pleased to support Troy's PDAC request which envisions making stronger use of their riverfront location while protecting and preserving the riverine system in alignment with MCD's core mission. The removal of the low dam will enable safer paddling, as well as allowing for a pedestrian path and kayak access on the south along East Water Street. MCD looks forward to working with Troy through the project design with the understanding Troy intends to implement the project so that flood control and protection remains a priority while encouraging stewardship and recreation.

Finally, Troy is a founding member of the Great Miami Riverway, which promotes economic growth along Ohio's first nationally-designated water trail, from Sidney to Hamilton, and which MCD is proud to administer and promote on behalf of twenty community partners along the Great Miami River. MCD is pleased to support Troy in its endeavors to continue to invest in sustainable riverfront development that helps advance the economic growth and quality of life in the region.

**RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE AND SAFETY OF TROY, OHIO, TO EXECUTE DOCUMENTS NECESSARY TO CONSENT TO THE REMOVAL OF THE LOW HEAD DAM ON THE MIAMI RIVER IN THE CITY OF TROY, OHIO**

WHEREAS, the City of Troy, Ohio owns a low head dam located on the Miami River in Troy, Ohio; and

WHEREAS, the United States Fish and Wildlife Service and the Ohio Environmental Protection Agency have held public hearings and determined that the removal of the low head dam will enhance recreational user safety, enhance fish passage, increase water quality, and enhance sediment transport for the Miami River; and

WHEREAS, funds are available from the Water Resource Restoration Sponsor Program to completely fund the removal of the low head dam without financial contribution from the City of Troy, Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Troy, Ohio, at least a majority thereto concurring as follows:

**SECTION I:** That the City of Troy, Ohio hereby consents to the removal of the low head dam on the Miami River by the United States Fish and Wildlife Service.

**SECTION II:** That the Director of Public Service and Safety of the City of Troy, Ohio is authorized to execute any and all necessary documents, use agreements, consents, and/or environmental covenants required by the United States Fish and Wildlife Service, Ohio Environmental Protection Agency, the Water Resource Restoration Sponsor Program, and/or the Miami Conservancy District for the removal of the low head dam, subject to the dam removal project being cost neutral to the City of Troy, Ohio.

**SECTION III:** That this Resolution shall take effect at the earliest date allowed by law.
